3. Publish a minimum of six peer-reviewed articles in high-impact journals (e.g., Q1/Q2 Scopus-indexed or A*/A-ranked ABDC journals) within the contract period.
4. Present research findings at international conferences or industry forums, if funding is available.
5. Co-author at least six grant proposals (e.g., national funding schemes or international collaborations) with the Fintech Impact Lab team, targeting a cumulative funding goal of MYR 120,000 or equivalent.
6. Co-author one white paper or policy brief annually for stakeholders based on research outcomes.
7. Organize or co-organize at least one workshop, seminar, or hackathon per year to foster knowledge transfer between academia, industry, and students.
8. Work with Lab Co-Director to identify and implement ways to contribute to Bank Negara's Fintech Regulatory Sandbox in Malaysia.
9. Contribute to the lab's visibility by maintaining an updated portfolio of research outputs on the lab's website.

2. Demonstrated expertise in fintech-related topics through prior publications or projects.
3. Strong track record of academic writing and presenting complex ideas to diverse audiences.
