Successful candidates will possess a PhD, or foreign equivalent, in Analytics, Information Systems, Computer Science, Management Science, or other related disciplines. The degree must be completed before September 2024. Experience in industry and/or government is a plus.

Analytics faculty at the School are active in research involving big data, management of AI, social media, social networks, sequential learning, collective intelligence, and financial technologies. Candidates are expected to complement and enhance the research activities of the school with their own scholarly activities, advise Ph.D. students, and are expected to publish in top journals of their field.
